**Detailed Instructions:** In well-written paragraphs, a total of 600–700 words, please address the following question with detailed reference to the text:

According to at least 2 of the following sources:

a) Suzanne Last Stone

b) at least three persons interviewed for the radio documentary “Faith in the Law” (briefly characterize and give the name of anyone whose views you cite),

c) Ayelet Shachar

what are some specific challenges posed by the issue of Jewish religious divorce (the *get*) for how we understand the separation of religion and secular law?

As was the case for prior assignments and the midterm exam, all your observations in the Text Preparation assignment should be backed up with references that allow your reader to see what they are based on in the text. For this purpose, please use in-text parenthetical page references—for an example of these, see Harvey, *Writing with Sources*, p. 51, under “MLA Basic Rules.”

Please print your assignment double-spaced and with one-inch margins, using an 11–12-point font. Please number and staple the pages you hand in. Please write “Text Preparation 5” at the top, and indicate the total word count at the end.

Note: Since this is your first reading of this text, and since we have not yet discussed it in class, the Text Preparation assignment is simply a first effort at figuring out what it says, and doing it will help you get the most of our in-class work on it. The assignment is not evaluated for whether it demonstrates a good understanding of the reading, but for evidence of your having worked in detail to understand the reading. Your fuller understanding will develop in the course of our class meetings, and with successive re-readings.
