Detailed Instructions: In well-written paragraphs, a total of approximately 600 words, please address the following question with detailed reference to the text:

How does McLachlin describe "law" and "religion," and how does she characterize the way they relate to each other, or should relate to each other?

Your answer may also include 1–2 questions raised in the reading for further discussion.

As was the case for the Text Summary assignment, your observations about the text should be backed up with references that allow your reader to see what they are based on; for this purpose, please use <u>in-text</u> <u>parenthetical page references</u>, as in this sample sentence:

Locke underscores that acts of violence are sometimes perpetrated "upon pretence of Religion" (23).

When quoting a source quoted in another source, please give the complete citation to the original source in a footnote and add the phrase: "as cited in McLachlin" [+page reference].

Please print your assignment to PDF, <u>double-spaced</u>, with <u>one-inch margins</u>, using an 11–12-point font, and with <u>no cover sheet</u>. Please write your name and "Text Preparation 1" at the top, and indicate the <u>total word count</u> at the end.

<u>Note</u>: Since this is your first reading of this text, and since we have not yet discussed it in class, the text preparation assignment is simply a first effort at figuring out what it says, and doing it will help you get the most of our in-class work on it. The assignment is not evaluated for whether it demonstrates a good understanding of the reading, but for evidence of your having worked in detail to understand the reading. Your fuller understanding will develop in the course of our class and tutorial meetings, and with successive re-readings.
