Honorary Degrees (Doctor of Laws)

At the Social Sciences Convocation Ceremony on June 12, 2019 the following Honorary Degrees were conferred:

Michael Dear began his career in McMaster's Department of Geography in 1974 before joining the University of Southern California as a professor in the Department of Geography and the School of Policy, Planning & Development. Two decades later, he moved to UC Berkeley where he is now professor emeritus in the College of Environmental Design. Dear is the founding editor of *Society & Space* and has served on advisory boards and committees for the Los Angeles Forum for Architecture and Urban Design and the Law Center for Regional Policy Studies UCLA. An elected member of the Canadian Institute of Planners and the Royal Town Planning Institute of Great Britain, Dear has received the American Planning Association (California Division) Award, the Association of American Geographers Distinguished Scholarship Award and the USC General Education Teaching Award.

James O'Reilly earned his law degree from McGill University and was called to the bar in 1964, soon after serving as president of the Junior Bar Association of Montréal. With specializations related to Aboriginal rights, treaty rights, land claims and self-determination of Aboriginal nations, he soon became one of Canada's leading legal advocates for Aboriginal peoples. O'Reilly piloted the landmark Superior Court case *Chief Robert Kanatewat et al. v. The James Bay Development Corporation et al.*, the case that led to the James Bay and Northern Québec Agreement between the Cree Nation and the Government of Québec. Following the repatriation of the Constitution in 1982, he was involved in amendments relating to Aboriginal interests. In 2004, O'Reilly was named Honorary Chief of the Samson Cree Nation of Alberta. He has also been named Avocat émérite by the Québec Bar. A fellow of the American College of Trial Lawyers, he has received the Medal of the Bar of Montréal.

Research and Scholarly Activities

The faculty in Social Sciences conduct internationally recognized research that tackles many of the most important social, political, and economic challenges today. The Faculty has particular strength in applied, policy- and community-focused research in partnership with diverse organizations, agencies and groups from the non-profit sector, the private sector, and all levels of government. These collaborations are especially strong at the local and regional level, but extend provincially, nationally, and internationally. Below are indicators of the quality and scope of our research activities.

Publications

In 2018 faculty in Social Sciences produced 197 individual publications. This represents a lower-bound for publications by Social Sciences faculty as it does not include certain types of research publications not captured in bibliographic databases, including reports and related documents for government and community partners. The identified publications took the following forms:

Research Funding

Social Sciences Internal and External Research Funding, 2018-19

In 2018-19, 62 Social Sciences faculty and post-doctoral fellows held research funding as principal investigators (PIs) valued at over **\$7.1 million**.^[1] Tri-Council Grants account for 61% of funds, external non-Tri-Council sources account for 67%, and the remaining 2% of funds were from internal McMaster funding.

Applications for Research Funding, 2018-19

2018-2019 the Faculty of Social Sciences, had considerable success with funding. Of the 13 SSHRC Insight Grants submitted in October 2018, 8 were awarded, for a 62% success rate. Of the 6 SSHRC Insight Development Grants submitted in February 2019, 3 were awarded, for a 50% success rate. Of the 3 faculty who applied to the new SSHRC Partnership Engage Grant program, 1 was successful, for a 33% success rate.

In total, Social Sciences faculty members and post-doctoral fellows submitted 62 applications for research funding as the Principal Investigator. 71% of these applications were successful, attracting over \$7 million in new research funding to the Faculty, 61% of which came from federal Tri-Council agencies, with the balance from other external funders and internal sources.

Undergraduate Teaching and Enrolment

Undergraduate enrolment in Social Sciences programs in 2018-19 was 3,850.78 FTE students. During the 2018-19 recruitment cycle, the Faculty received 6,699 applications for admission to level 1 programs, made an offer of admission to **4,292** of those applicants (64.1%), and received confirmation of acceptance from **1,095** of them (25.5%).

Experiential Education

The Faculty of Social Sciences offers varied and enriching experiential-education opportunities for our students that promote strong connections between academic studies, career exploration, and community involvement.

Our experiential programming falls into four broad areas of activity: (a) supporting students' professional development; (b) experiential placements in workplace settings; (c) awards and funding to support students' experiential learning; (d) and partnering with community organizations to provide students with community-engaged learning opportunities.

Financial Matters

Faculty of Social Science Budget

The table below presents high-level statement of our finances for 2018-19. A few aspects are noteworthy:

- Over 90% of FSS revenue is derived from tuition and government funding for students enrolled in our programs and students we teach in our courses
- Over 40% of our revenue was paid as contributions to support central university support services, which range from heat to human resources to the library and to the President's Office.
- Aside from these central contributions, over 90% of FSS expenditures are for people: faculty, staff, and TA support
- Over the last few years the Faculty has been able to eliminate its accumulated debt, and we now have a modest accumulated surplus, which is integral to our fiscal sustainability go forward.
